

# ***Registration form for Exhibitors Euregio Koi Show 2022***

## **1. Participation**

Participation in the Euregio Koi Show is possible for anyone who fits into the concept of the Show. All necessary show information is also available on our website: [www.euregiokoishow.nl](http://www.euregiokoishow.nl)

The payment must be made to the account of Koi Club, The Netherlands, before the given date shown on the invoice. The allocation of the stand is carried out exclusively by the members of the Board of Koi Club, The Netherlands. Koi Club, The Netherlands determines the place where your pitch will be and this is not transferable. Your pitch is not allowed to be assigned to anyone else, whether for payment or otherwise, this will result in an increase of the rent price by a 100% with regard to the article 3.

## **2. Refusal**

The Board of Koi Club, The Netherlands, as well as all its authorized persons, has the right to refuse anyone access to the show grounds, the intermediate path from the car park to the show site and also participation in the show.

## **3. Payments**

After receipt of the invoice, payment must be made within eight days. Upon receipt of the membership fees is the final location assigned by the Board of Koi Club, The Netherlands. Late payment can result in a different location than requested. Per stand is a charge €50.00. After dismantling your stand, it will be inspected by the organization. If your stand is delivered clean, you will be refunded the €50.00 deposit. You can only receive the cash deposit on Sunday, 7 June or Monday 8 June.



#### **4. Termination**

Cancellation is only possible in writing, eight weeks before the show, stating clearly the reasons for cancellation. This must be sent by registered post to the person in charge of Koi Club, The Netherlands. Hereafter 50% of the already paid rental fee is non-refundable. However, if cancellation takes place after this period, a refund is not possible. Unpaid rent remains owed to Koi Club, The Netherlands, in accordance with article 3. 5.

#### **5. Assembly and dismantling**

The Exhibitor may build the stand on Friday 10 June, 2022 from 09:00am until 19:00pm. Before 19:00pm you must leave the showground. In consultation with Koi Club, The Netherlands it may be possible to build the stand on Thursday 9 June, 2022.

Cleaning up and breaking down the stand is allowed on Sunday 12 June 2022 after 17:00pm, or on Monday 13 June, 2022, between 08.00am and 13.00pm. Material that is left on site will not be supervised by Koi Club, The Netherlands.

During the show it is forbidden to clear the stand! The stand must remain open to the public. If the stand is not open, you will not be refunded the entry fee.

The stand must be built on the rented location.

It is forbidden to exhibit any articles outside of this location, without permission of Koi Club, The Netherlands, or by its authorized persons.

You can only hang up your articles ON your own stand **WITHOUT** damage to your and other stands, with fasteners to the pipes and not to the cloth itself.

Only banners, flags and signs for which sponsors have paid for by the organization can be hung up on the show site. All unpaid articles owned by yourself and hung outside your own stand, will be removed immediately!

It is expressly forbidden to run water over the terrain, before, during and/or after the show. If this is the case, the damage done to the premises, property or third parties, will be charged to the stand holder.

To prevent damage to the terrain, trailers and trucks are not allowed on site.

We therefore ask you to remove the vehicles from the terrain as soon as you have loaded and unloaded. The stand should be completely empty (no waste) and be left fully intact.

#### **6. Koi Sales/Filters**

All sales tanks containing live fish must be fitted with a reliable filter system with sufficient capacity. The Exhibitor shall ensure that the fish that are kept on the stands are kept from springing out of the tanks. If, in the absence of the Exhibitor, this should happen, the fish are then the property of Koi Club, The Netherlands. Koi Club, The Netherlands shall ensure the quality of housing and the health of the fish offered for sale. If Koi Club, The Netherlands is of the opinion that the sale is irresponsible, they will take appropriate action and demand that the Exhibitor immediately stops the sale of the fish.



## **7. Unforeseeable situations resulting in cancelling the show**

Whenever situations are outside their power, the Board of Koi Club, The Netherlands, will cancel the show entirely. For example, the death of one or more of the members, a day of national mourning, natural disasters or any other event that could lead to cancellation. The Euregio Koi. Fees already paid to Koi Club, The Netherlands will be refunded minus the costs incurred by Koi Club, The Netherlands, for the benefit of the participant. Koi Club, The Netherlands, however, is not liable for the costs incurred by the Exhibitor for the benefit of the show, or loss of earnings.

## **8. Catering**

On the grounds of the show it is not allowed to offer or exploit drink and/or food, unless otherwise agreed and confirmed in writing with Koi Club, The Netherlands.

## **9. Vehicles and parking**

Only on the indicated route and/or direction of Koi Club, The Netherlands is it allowed to drive with a vehicle (engine). It is forbidden to drive or park in front of the tents. Loading and unloading must be carried out via the paved road at the rear. All vans, trailers, motorcycles and other vehicles must leave the terrain no later than Saturday, June 11 at 9:00am, 2022, to the indicated car park. Only with instructions given by the authorized persons, is it allowed on Sunday 12 June, 2022, after 17:00pm to drive your vehicle over the show terrain Further instructions about this during the show.

## **10. Audio and video**

It is allowed to use audio and video material, provided this is not a nuisance to Exhibitors close by or the organization. Also please note the legal guidelines imposed by Buma Stemra. This should be arranged by the Exhibitor self with the competent authorities. Koi Club, The Netherlands takes no responsibility.

## **11. Electricity**

The stand is equipped with adequate an supply of electricity. The exhibitor is obliged to only use proper and approved (according to CE cq NEN 1010) equipment in this installation. (extension cable up to 25m has to be provided by the Exhibitor). For any damage caused by equipment connected to this installation is Koi Club, The Netherlands, not liable. Per stand should be max. 500 watts in the installation. Because of the high wattage is not allowed to bring your own coffee machine. For exhibitors there will be coffee available for an additional charge at the club tent of Koi Club, The Netherlands.

## **12. Monitoring**

The show site will be guarded from Tuesday 2 June, 2022, at 20:00pm, until Monday 13 June 2022, at 09:00am and during the closing hours. The delegated security guards of Koi Club, The Netherlands, will be on the premises during the whole show and should not be denied access to the stands. The security guards shall have the power to do all necessary for the safety of visitors and participants. The instructions given by the security service must be followed.



### **13. Risk and Rights**

- a) The management of Koi Club, The Netherlands and/or its employees is/are not liable for any damages or loss, for whatever reason, during the show.
- b) The Exhibitor as well as their employees are liable for all damages and/or loss of any kind incurred before, during or after the show. Howsoever arising in or by their stand as well as for all damages caused with or through their business, vehicles, by their actions, or by their failure on or in the immediate vicinity of the show site. Koi Club, The Netherlands accept no responsibility whatsoever and shall be entitled to damages resulting from claims by third parties directly to the exhibitor and/or his staff. Under employees, shall also mean those who are as such.
- c) Koi Club, The Netherlands, are not liable in any way for damages, illnesses and/or deaths at Koi that are present at the show or during transport to and from the show.
- d) The participants are absolutely not allowed to advertise and/or make any announcements outside of the rented area.
- e) Participants are required to be open for the public, at all times during the show.

### **14. Deviations**

Deviating from the terms and conditions of the Euregio Koi Show 2022, is only possible after written consent from the Board of Koi Club, The Netherlands.

### **15. General**

It is expected that the Exhibitor knows and understands the conditions of the “terms and conditions” and is also in possession of it. At registration you also agree to be bound by these terms and conditions subject to text and printing errors.
